About the Seminar

Since 1981 the Central Bank of Barbados' Annual Review Seminar has provided a stimulating and thought-provoking discussion forum for economists, academics and practitioners in the areas of economics, finance and related areas.

This year it is our pleasure to invite you to our 39th Annual Review Seminar to be held from July 24th – 26th, 2019 in Barbados.

Seminar Theme

The global economy has benefitted from large scale economic innovation, where evolving institutions, technology and ideologies have translated into increased productivity and growth. In many ways this has not been evident in the Caribbean context where growth continues to be moderate. Given this, a paradigm shift in economic policy and processes may be necessary to unlock new levels of competitiveness in the region. This year's theme **"Critical Minds for Critical Times: Economic Research as a Building Block for Transformative Growth in the Caribbean"**, seeks to encourage researchers to

consider Caribbean centric research that can be influential to national or regional economic policies, as inputs to fostering transformative growth. Persons not presenting a paper, but interested in our stimulating and policy-oriented discussions, are also invited.
