ORDER

ENTERED on the 1st day of April 2021.

BEFORE: The Honourable Sir Patterson Cheltenham KA, Chief Justice who considered the Application on the 30th day of March 2021.

AND UPON READING the Application together with the affidavit in support with exhibits of Mr OLIVER THOMAS, Senior Crown Counsel sworn and filed on the 30th day of March, 2021;
AND UPON DETERMINING that this matter be deemed fit for an urgent hearing;
AND UPON HEARING Ms OLIVIA M. DAVIS, Attorney-at-Law for the Claimant.

IT IS HEREBY DECLARED that: Pursuant to **section 10B** of the **Anti-Terrorism (Amendment) Act, 2019-34**, the Defendants and Entities, listed on the United Nations Security Council Sanctions List pursuant to Security Council Resolution 2231 (2015) be listed as entities or other groups for the purposes of the **Anti-Terrorism (Amendment) Act, 2019-34**.

IT IS FURTHER ORDERED that:-

1. Service of this Order be dispensed with;
2. a Counter-Proliferation Order be granted against the Defendants pursuant to **section 10B** of the **Act**;
3. pursuant to **section 10B(1)(3)** of the Act the following are frozen :-
 - a. any property of the person or entity against whom the Counter Proliferation Order is made;
 - b. property that is wholly or jointly owned or controlled, directly or indirectly, by the person or entity against whom the Counter Proliferation Order is made;
 - c. property that is derived or generated from other property owned or controlled, directly or indirectly, by the person or entity against whom the Counter Proliferation Order is made;
 - d. property of a person acting on behalf of, or at the direction of, the person or entity against whom the Counter Proliferation Order is granted
4. the defendants be prohibited whether directly or indirectly, from possessing, controlling or having access to any property in Barbados;
5. the Registrar of the Supreme Court do serve a certified copy of the Order on the Financial Intelligence Unit (FIU) immediately;
6. the Court dispense with service on the Defendants of any Order made;
7. Costs to be costs in the cause;

8. All such further Orders or directions as the Court deems fit for securing and enforcing the Counter Proliferation Order sought in the circumstances of the case; and
9. Liberty to apply.
